

**MINUTES OF THE LYMAN TOWN COUNCIL MEETING

**1. CALL TO ORDER:**

**Police Department –**

**Fire Department –**

Chief Jim Redd and presented the monthly report, and the complete report summary is attached in the permanent file. Total of 71 calls, 32 inside, with 5.4 minute average response time. Wetzel mentioned that Municipal Association having a dilapidated building act, and contacted Redd and Harter to hear. Redd said that in 1<sup>st</sup> quarter 21 new homes inside the Town.

**Public Works –**

Alan Johnson presented their monthly report with the complete report summary attached in the permanent file. Chappell asked about the spike in C&D waster, Johnson responded that was due to Old Community Center where gentleman was doing own work.
